Halcyon Shades offer unrivaled solar protection, flexibility and performance with emphasis on safety.

Halcyon Shades are designed to comply with the American National Standard for Safety of Corded Window Covering Products, (ANSI/WCMA A100.1 2002) sponsored by the Window Covering Manufacturers Association.

When properly installed, the cord tension device provided with the Halcyon Shades can prevent a child from pulling the cord around its neck.

Materials used in Halcyon Shades contain less than .02% lead per weight per window covering.

Halcyon Shades will not pull free during use when the mounting clips are properly installed.

Halcyon Shades material is warranted for the periods specified below from the date of original purchase when properly installed as an interior shade in accordance with manufacturer's instructions. Halcyon Shades material will maintain reflective properties without crazing or cracking.

Halcyon Shades Embossed.....5 Years

Halcyon Shades Traditional.....3 Years

Seller shall not be liable under any circumstances for any damage or reduction in performance directly or indirectly resulting from misuse or improper application or daily wear and tear.

The warranty coverage is limited to the owner of the property at the time of installation and is not transferable.
